A Tuition Contract must be completed each school year and submitted with the Registration Fee.

Grades K-12:

Tuition Payment Options: Each family must designate a payment option annually on the Sacred Heart Catholic School Tuition Contract. Options are:

1. Pay tuition and the building fee in full by July 15, 2019.
2. Pay ½ tuition and ½ building fee by July 15, 2019 and the balance of ½ tuition and ½ building fee by January 15, 2020.
3. Pay tuition in 12 monthly installments through automatic bank account debits to FACTS (tuition management company). A \$45 non-refundable, annual enrollment fee is automatically deducted from the bank account within 7-10 days of activation. The fee will be deducted from the bank account each year thereafter in July, unless notice is given to the school business office by June 1st. The first tuition payment for 2019-2020 will be debited on July 20, 2019, with each additional payment debited on the 20th of each month, ending with the June 20, 2020 payment. If the 20th of the month falls on a Saturday or Sunday, payment will be withdrawn on the following Monday.

Tuition and Fee Requirements Upon Withdrawal: If a student withdraws from Sacred Heart Catholic School at any time during the school year, tuition will be collected for the month in which the student withdraws and two months thereafter. All fees are non-refundable.

A monthly \$25 late fee will be assessed on accounts 30 days past due. A 5% fee will be added to all credit card transactions.

Sacred Heart offers three options for tuition payment. Please choose one of the following:

- OPTION 1**
Pay tuition and the building fee in full by July 15, 2019.
- OPTION 2**
Pay ½ tuition and ½ building fee by July 15, 2019 and the balance of ½ tuition and ½ building fee by January 15, 2020.
- OPTION 3**
Pay tuition in 12 monthly installments through automatic bank account debits to FACTS (tuition management company). A \$45 non-refundable, annual enrollment fee is automatically deducted from the bank account within 7-10 days of activation. The fee will be deducted from the bank account each year thereafter in July, unless notice is given to the school accountant by June 1st. The first tuition payment for 2019-2020 will be debited on July 20, 2019, with each additional payment debited on the 20th of each month, ending with the June 20, 2020 payment. If the 20th of the month falls on a Saturday or Sunday, payment will be withdrawn on the following Monday.

Tuition and Fee Requirements Upon Withdrawal: If a student withdraws from Sacred Heart Catholic School at any time during the school year, tuition will be collected for the month in which the student withdraws and two months thereafter. All fees are non-refundable.

Late payments and/or returned payments may be subject to additional fees by the school, bank and/or FACTS. A monthly \$25 late fee will be assessed on accounts 30 days past due. A 5% fee will be added to all credit card transactions.

By signing below I/we acknowledge that I/we have read and fully understand the non-refundable fees, tuition costs and terms outlined in this contract and the "Tuition and Fees" document. I/we further understand that I/we am/are fully responsible for the payment of all tuition and fees. In the event that the parish/school must take action to recover unpaid balances, I/we understand that, in addition to the unpaid tuition and late fees, I/we am/are also responsible for all expenses and costs for such actions the parish/school make take including attorney and court fees incurred for collection.
